





Branch Campus in Carthage

Meet with an Academic Advisor

Each term, prior to registration, you will meet with your academic advisor to discuss courses for the upcoming semester. Academic advisors are assigned to students according to degree or program. Your advisor is a valuable information resource and will keep you up to date on program requirements, college graduation requirements, and transfer coursework.



Sandburg uses a tool called Student Planner that allows advisors to help students plan classes to meet their degree requirements. You must meet with an advisor to register for classes; it is your responsibility to schedule an advising appointment before registration begins. Early advising will give you more scheduling options. Your instructors can also help with course suggestions. Watch for registration notices and make your appointment early to avoid significant wait times. Appointments are available face-toface, over the phone, or via Zoom. **Galesburg 309.341.5237**, **Carthage 217.357.3129**.

Registering for Classes

All Sandburg students are required to meet with an academic advisor to register for classes. Appointments are available face-to-face, over the phone, or via Zoom. New students must complete the Steps to Enroll prior to meeting with their assigned advisor. Current students can meet with their academic advisor prior to registration to complete Student Planner, which allows for online registration with the advisor's approval. Paying Your Bill

The College accepts Visa, MasterCard, Discover, or American Express for tuition and fees payment. Tuition deadlines will be posted on our website and around campus. We will send out postcards, bills, or phone calls at least two weeks prior to the tuition deadline. You can make one or multiple payments to the Business Office as long as you have arranged to pay your tuition in full by the deadline. Failure to pay your tuition balance in full by the deadline may result in being dropped from your classes. Payment for classes added after the tuition deadline is due at the time of enrollment. Carl Sandburg College accepts tuition payments online, by phone, by mail, in person and by certain third-party entities. The College also offers a monthly payment plan. Students can view their current tuition balance and tuition deadlines via mySandburg. View your bill and payment plan options by contacting the Business Office at **309.341.5210** or online at **sandburg.edu/Services/Business-Office**.

- Adding or dropping a course
- How to plan for transferring to another college or university
- What you need to do to graduate
- Balancing school with the other demands on your time

New Student Orientation

All first-year Sandburg students participate in Charge Up! New Student Orientation prior to the start of their first semester. Orientation is a 3.5-hour session that covers a comprehensive technology check of the student portal, an interactive tour to locate classrooms and key areas of campus, an in-depth discussion about classroom expectations, and other important information to know before classes begin. Once advisors approve the sections, students may register themselves when registration opens.

Student ID Card HOW DO I GET MY SANDBURG ID CARD?

Bring your student schedule with your ID number printed on the page to the Public Safety Office at the Main Campus or the Branch Campus Library in Carthage. Your ID number will be entered to verify that you are enrolled in classes. Your picture will be taken and your card printed within five minutes.



WHERE DO I GET MY SANDBURG ID CARD?

Students can pick up their student ID in the Public Safety Office in the Student Center at the Main Campus. Branch campus students can get their student ID in the library.

WHY DO I NEED A SANDBURG ID CARD?

Your ID card provides proof of your status as a student or employee at the College.

WHAT DO I USE MY SANDBURG ID CARD FOR?

- Library card
- Free admittance to athletic and theater events
- Any transactions in Student Services (Financial Aid, Business Office)
- Admittance to the Fitness Center
- Food Service add money to your card to use at Boxcar Express
- Ride the bus for FREE

HOW DO I PUT MONEY ON MY SANDBURG ID CARD TO USE FOR FOOD SERVICE?

Bring your Sandburg ID and your money to either Boxcar Express location. The money will be added to your Sandburg ID at the cash register. You may also add money to your Sandburg ID for Boxcar Express in the Business Office.





Parking on Campus

The Main Campus in Galesburg has five large parking lots. Parking is provided at no cost. No parking is allowed on the sides of the entry roads, in fire lanes, or on lawn areas. Tickets will also be issued for taking up two parking spaces and for parking over the lines. In addition, each parking lot has parking spaces designated for handicapped parking. Unauthorized use of these parking places will result in a \$250 fine in accordance with paragraph 11-1301.3 of the Illinois Vehicle Code.

The Risk Management Committee of the College serves as the appeals board for persons issued a parking violation. This committee meets each month, and its membership is comprised of students, faculty, and staff. Parking violation fines must be paid within 10 days. Appeals may be made only AFTER the fine has been paid. Appeal forms may be picked up in the Business Office.

Bus Schedules STUDENTS WITH ID CAN RIDE FOR FREE

Sandburg students enrolled in credit classes can ride the Galesburg Transit city bus service for free by showing a current Sandburg ID. For more information about how to ride for free, contact the coordinator of student life at 309.341.5332. Galesburg Transit's bus service includes Sandburg on its daily route Monday-Thursday and on Fridays and Saturdays by request. The route comes through the College approximately 30



minutes past each hour from 7:30 a.m.-5:40 p.m. and stops at the bus shelter outside Building A and the circle drive outside Building D. TIPS FOR SUCCESS

TIPS FOR SUCCESS



1. Read Your Syllabus and Attend Class Every instructor will provide you with a syllabus, which is an outline of your class. The syllabus will contain important

dates, instructor expectations, and instructor contact information. Attendance policies may differ for each class. Your instructor will expect you to be familiar with the syllabus, so please ask if you have any questions! It is critical to attend class. Your instructor will notice and you will be graded for participation







Expect your study time to double or even triple in college. You will have labs, group projects, research papers, and final exams. You will need to balance your academic responsibilities with work, friends, and family. At Sandburg, you have many resources, including instructors, academic advisors, personal counselors, and our Tutoring Center. Take advantage of your support systems...everyone needs help sometimes in college!

3. Get to Know Your Advisor

Your advisor will help you with course selection and completion of your degree or certificate. You must see your advisor to register and when you need to change your schedule. Your advisor is available by phone, email or Zoom to answer questions about transfer schools, programs, and careers.

4. Learn How to Learn

Time management is key for college students. "Last minute" is never a good idea and will raise your anxiety level. College-level work requires you to develop your critical thinking skills; be prepared to try new study techniques and visit the Tutoring Center to learn new strategies.

5. Ask Questions

Successful students ask questions. Everyone at Sandburg is committed to helping students succeed. Instructors, advisors, and staff welcome and encourage questions.

6. Get to Know Our Library

The Library offers many resources in addition to books and scholarly articles. It is also home to the Tech Help Center on the Galesburg campus. Get help with Moodle, email and online classes. Librarians can help you with test prep materials and career information. They can also reserve study rooms for you or your study group.











7. Academic Support = Better Grades

Academic Support benefits all students at Sandburg. Check in with the Academic Support office if you are a student with a disability or if you want to use our free Tutoring Center. Twenty-four hour online tutoring is available through Brainfuse on your mySandburg page.

8. Get Familiar with Campus Policies

Look for notices and be aware of important campus policies that affect your success at Sandburg. For example, the "No Show, You Go" policy applies to all students at the start of each semester. This policy states that students who fail to attend class for the first four days of the semester will be dropped from classes. Ask an advisor, instructor, or staff member if you have questions regarding campus policies.

9. Financial Aid is Your Friend

Most students rely on financial aid to get through college. The Financial Aid office will keep you up to date on eligibility requirements and deadlines. Did you know financial aid-eligible students are required to keep a 2.0 grade point average, complete 67% of credit hours attempted, and complete their degree or program within a maximum timeframe? The staff in the Financial Aid office will help you stay on track.

10. Dropping a Class?

During the course of your college career, you will have questions about dropping/withdrawing from a class. Always speak with your instructor before dropping a class. Your instructor may have ideas about how you can be successful in the class. If you want to pursue dropping a class, you must speak with your advisor. Please see Page 20 for procedures and FAQs on withdrawing from a class.

11. Petition to Graduate

Finally, after checking in with your advisor, you will be ready to petition to graduate. If you will have enough credit hours to graduate at the end of the semester, contact assistant registrar Angela Snow at **309.341.5233** or **asnow@sandburg.edu**.

Building Your Class Schedule

Here are some tips to make sure you get the most out of your classes:

- Study the course schedule on the website, which lists each class being offered, the time, the format, location and instructor (if available).
- Meet with your advisor for valuable assistance and information unique to your degree plan.
- Take classes in the correct sequence.
- Check the course descriptions for any prerequisite courses/important information.
- During registration, classes fill on a first-come, first-served basis. Have some alternative classes in mind in case your first choices are full.
- Students who plan to transfer to a four-year university should follow the degree plan from their anticipated transfer institution. To gather the best information, contact your transfer school as early as possible for advice on what courses will transfer toward your degree and to become familiar with any transfer equivalency guides, articulation agreements, and Sandburg's core curriculum guide.

Starfish Early Alert

Sandburg uses Starfish to communicate with students regarding their academic progress. The purpose of Starfish is to communicate with students EARLY in the semester and to keep you informed of your progress in your class. The system is not intended to punish you for poor performance. Starfish promotes success in the classroom.

WHY DO WE USE STARFISH?

We want all Sandburg students to successfully complete their degrees or certificates. The Starfish software allows faculty to easily communicate their concerns and progress notes to you as well as the staff in your Success Network. This is a group of people at Sandburg concerned with your success. This includes all of the current faculty members, your advisor, student success coach and, if you are an athlete, your coach.

- You need to check your Sandburg email routinely.
- Your instructor will send you a flag or a kudo through the Starfish program.
- You can also set up text alerts to go to your mobile phone notifying you when you receive a flag or kudo.

REQUEST HELP THROUGH STARFISH

Starfish has a feature called "Request Help" that allows students to be proactive in seeking assistance. Login to your Starfish account, click on the menu button, and then select "Request Help" on the left side navigation.

Strategies for Academic Success

At Carl Sandburg College, we want you to achieve your goal of graduating with a college degree or certificate. Here are a few steps you may take to help make your path to success easier:

Go to class prepared for the discussion and ask questions to clarify the information.

SCHEDULE PLANNING GUIDE

- Meet with your instructors after class or during their office hours for additional help.
- Go to the Tutoring Center or use our online tutoring through Brainfuse for assistance with course material. You can find a Brainfuse link in mvSandburg.
- Meet with your academic advisor to discuss your concerns and update them on your academic progress.
- Form a study group with other students in the class to prepare for tests.
- Check your Sandburg email every week for Champ the Charger emails and the Starfish emails from your instructor.
- At the first indication you might have a problem with a class, speak with your instructor; they are your best resource! If you have a personal problem, contact Student Services to speak with a counselor.

WITHDRAWING FROM CLASS?

If it appears that you will not be successful in a class, it is often better to withdraw from the class than receive a poor grade that will be part of your permanent record. You should meet with your instructor and advisor to discuss your options prior to officially withdrawing. Withdrawing from a class may protect your GPA; however, these actions can have other serious consequences that might affect your enrollment, financial aid, or student employment status. If you are on financial aid, you should speak with someone in the Financial Aid Office before you withdraw from a class to find out whether there will be an impact on your financial aid.

ARE ALL WITHDRAWALS THE SAME?

No. When you drop a class before the 100% refund period, the class is completely removed from your academic record and you're eligible for a full tuition refund. If the 100% refund period has passed, you may still withdraw from a class up to the last date to withdraw, as indicated on the academic calendar. If you withdraw, a "W" will be recorded on your transcript. It will have no effect on your grade point average. Tuition refunds will be issued to eligible students based upon effective date of withdrawals. Please see the "Refund Schedule" in the "Sandburg Glossary" on page 31.

IF I QUIT ATTENDING CLASS, WILL MY INSTRUCTOR AUTOMATICALLY WITHDRAW ME?

No. Instructors may administratively withdraw students from their classes up to midterm, but they are not required to do so. You are not automatically withdrawn from a class for non-attendance. If you wish to withdraw from a class, you must follow the official process. If you do not withdraw from a class and your instructor doesn't administratively withdraw you by midterm, you most likely will receive a failing letter grade for the class.

ISSUES WITH INSTRUCTORS

Students who have concerns or complaints about the course instructor should follow a specific process. We encourage you to first speak with the instructor. While most issues are resolved at this level, if a problem continues, the next step is to speak to the dean or associate dean of the program area. On the rare occasion that the issue is not resolved at the dean/associate dean level, students may contact the vice president of academic services.

HOW WILL NOT ATTENDING AND/OR WITHDRAWING FROM ALL OF MY CLASSES AFFECT ME?

Students who quit attending all of their classes prior to completing 60 percent of the term may have to pay back financial aid money received for the term. This can result from administrative withdrawals, as well as student withdrawals. The Financial Aid Office reviews a list of students with grades of "W" and "F" at the end of the term and adjusts financial aid when required. HONORS PROGRAM

The Honors Program is designed for exceptional students who excel in college. Honors courses are intellectually challenging and involve considerable interaction among students and instructors. Certification as a Carl Sandburg College Honors Program graduate requires that students participate in two Honors courses and complete an Honors Project.

There are many ways to be eligible to apply for the Honors Program. Students may apply if they meet one of the following criteria: a cumulative high school GPA of 3.5 or higher, top 10% of their high school class, a 25 or above on the ACT, a combined score of 1000 on the SAT, 12 college transfer credits with a minimum 3.25 GPA or a recommendation from a Sandburg instructor or counselor.

Through a new articulation agreement with Western Illinois University, students completing 12 hours of honors coursework at Carl Sandburg College may be eligible to transfer into the Centennial Honors College and graduate as a General Honors Scholar at WIU. PARKING REGULATIONS

The Main Campus has five large parking lots. Parking is provided free. No parking is allowed on the sides of the entry roads, in fire lanes or on lawn areas. Tickets will be issued for taking up two parking spaces and for parking over the lines. Tickets will be issued for violation of these parking rules. In addition, each parking lot has parking spaces designated for handicapped parking. Unauthorized use of these parking places will result in a \$250 fine in accordance with paragraph 11-1301.3 of the Illinois Vehicle Code.

PERSONAL COUNSELING

The counseling staff at the College provides short-term counseling services for students facing personal or family problems. The special skills and training of the counseling staff enable them to work with students on an individual basis or in a group setting. Carl Sandburg College provides safety and security needs of staff, students and visitors through the Public Safety Department with officers who are on site on the Main Campus 24 hours per day, 365 days per year. Any person who witnesses a crime or becomes a victim of a crime should report it as soon as possible to Public Safety. When multiple incidents occur during the same time frame, reports and subsequent action by Public Safety officers are handled in order of priority: 1) personal safety; 2) property crime; 3) services. REFUND SCHEDULE

Tuition refunds will be issued to eligible students based upon effective date of withdrawals. The date that a written request for withdrawal is received by the Admissions and Records Office determines the effective date of withdrawal. Full refund of tuition and fees will be made if the College cancels a course. Refunds will be determined on the basis of the following schedule:

STUDENT GOVERNMENT ASSOCIATION

The Student Government Association (SGA) is the officially recognized student governance body for Carl Sandburg College. Student Equal Opportunity Regulation

It is the regulation of Carl Sandburg College that a student's race, color, religion, sex, national origin, ancestry, age, disability, citizenship, marital status, veteran status, sexual orientation or status in any group protected by applicable federal, state or local law (unless a part of a College affirmative action initiative), shall not be a basis for determining: (1) whether the student will be admitted to the College; (2) the educational performance required or expected of the student; (3) the attendance or assignment requirements applicable to the student; (4) to what courses, fields of study or programs, including honors and graduate programs, the student will be admitted; (5) what placement of course proficiency requirements are applicable to the student; (6) the quality of instruction the student will receive; (7) what tuition or fee requirements are applicable to the student; (8) what scholarship opportunities are available to the student; (9) what extracurricular teams the student will be a member of or in what extracurricular competitions the student will participate; (10) any grade the student will receive in any examination or in any course or program of instruction in which the student is enrolled; (11) the progress of the student toward successful completion of or graduation from any course or program of instruction in which the student is enrolled; and (12) what degree, if any, the student will receive. Questions or concerns should be addressed to the vice president of student services during regular business hours.

Students Rights and Responsibilities

Carl Sandburg College recognizes that students are citizens as well as members of an academic community. As a citizen, each student has the freedoms of speech, assembly, association, the press and the rights of petition and due process, which are guaranteed by the state and federal constitutions. As members of an academic community, students have the right and responsibility for participating in the formulation and review of all college regulations and policies directly affecting them. Upon enrolling in the College, each student assumes an obligation to conduct himself/herself in a manner that is compatible with the College's function as an educational institution. If this obligation is neglected or ignored by the student, the College must, in the interest of fulfilling its function and meeting its total obligations, institute appropriate disciplinary action as outlined in the Carl Sandburg College Policies and Regulations Manual.

Student Code of Conduct

The College expects from its students a higher standard of conduct than the minimum required to avoid disciplinary action. Students are expected to obey the law, to show respect for properly constituted authority, to perform contractual

obligations, to maintain integrity and a high standard of honor in academic work and to observe a standard of conduct appropriate for the College. The College expects all students to conduct themselves under all circumstances in a responsible manner. This implies thoughtful consideration of College property and members of the College community. Any student or group of students failing to observe either the general standards of conduct or any specific regulation adopted by the College or acting in a manner not in the best interest of other students of the College, shall be subject to disciplinary action. Copies of the Student Code of Conduct Procedure on Disciplinary Due Process are available in the Student Services Office.

Framework for Addressing Student Concerns

Should the student have a complaint an issue believed to have an adverse effect upon the student, someone else or a group of students—the student may work to address that problem by first bringing the issue to the attention of the person(s) against whom the complaint is directed. If resolution is not reached, complaints should be directed to the immediate supervisor or dean of the person against whom the complaint is directed.

If no resolution is reached at this level, the student may submit a formal written appeal to the proper vice president. All decisions, notification of decisions and reasons for decisions shall be in writing.

This procedure shall not apply to complaints filed on the basis of gender-based discrimination and/or sexual harassment.

FORMAL COMPLAINT SUMMARY AND ANNUAL REVIEW PROCEDURES:

- Each vice president will compile a list of formal written complaints received and submit to the senior executive assistant to the president, who aggregates the data into a master document.
- Complaints are reviewed by the president's cabinet to see if patterns emerge which reveal a need for improvements in programs, activities or services

Academic Dishonesty

Students at Sandburg are responsible for understanding what constitutes academic dishonesty.

Carl Sandburg College defines academic dishonesty as proposed by Gary Pavels [Kibler, et al, (1988, p.1) Academic Integrity and Student Development: Legal Issues and Policy Perspectives. North Carolina: College Administrative Publications, Inc.]:

CHEATING

Intentionally using or attempting to use work that is not your own, unauthorized materials, information or study aids in any academic exercise. The term academic exercise includes all forms of work submitted for credit or hours.

FABRICATION

The intentional and unauthorized falsification or invention of any information for citation in an academic exercise.

FACILITATING ACADEMIC DISHONESTY

Intentionally or knowingly helping or attempting to help another violate a provision of the institutional code of academic integrity.

PLAGIARISM

The reproduction of ideas or words or statements of another person as one's own without acknowledgement. The penalties for academic dishonesty may be severe. Students are advised to contact their instructors for policy clarification for a specific class.

Academic Progress

ACADEMIC WARNING:

Students will be placed on Academic Warning if their cumulative GPA falls below a 2.0 or if their cumulative completion rate of courses attempted drops below 67%. Students who are placed on Academic Warning must demonstrate progress toward degree completion during their next semester of enrollment by earning a semester GPA of 2.0 and a semester completion rate of 67%. Students who are placed on Academic Warning may continue to enroll in classes and receive financial aid.

ACADEMIC NOTICE:

Students previously placed on Academic Warning who fail to meet the Standards of Academic Progress will be placed on Academic Notice. Any student placed on Academic Notice must complete the next semester of enrollment with a 2.2 GPA and achieve a 75% semester completion rate to remain on Academic Notice. Students on Academic Notice and who meet the minimum GPA and completion requirements will be permitted to enroll in the upcoming semester even if the student's cumulative GPA and cumulative completion rates remain below the required levels.

Students placed on Academic Notice are strongly encouraged to schedule a meeting with their academic advisor to develop an academic plan that will allow the student to complete his/her program in a timely manner.

Students placed on Academic Notice may be eligible to receive financial aid if they are approved to participate in the Academic Improvement Plan (AIP) through the Office of Financial Aid. Students interested in learning more about the AIP are advised to contact the Office of Financial Aid for specific program details.

Students who have been placed on Academic Notice and who earn a semester GPA below a 2.2 and/or whose completion rate is below 75%, will be placed on Academic Notice II.

ACADEMIC NOTICE II:

Students placed on Academic Notice II are allowed one additional semester to improve their academic standing. Students who fail to make significant improvements may be suspended from the College for the following semester and must appeal to be permitted to enroll for future classes.

Students placed on Academic Notice II are required to schedule a meeting with their academic advisor to re-evaluate and to revise the student's existing academic plan. Students placed on Academic Notice II will be restricted to enrolling in no more than 12 credit hours per semester. A registration restriction will be placed on the student's account so that additional courses may not be added. Students on Academic Notice II must complete the semester with a 2.2 GPA and achieve a 75% semester completion rate to remain on Academic Notice II. Students on Academic Notice II and who meet the minimum GPA and completion requirements will be permitted to enroll in the upcoming semester even if the student's cumulative GPA and cumulative completion rates remain below the required levels.

The performance of students placed on Academic Notice II will be reviewed by the committee at the conclusion of each semester. Students whose performance failed to improve will be placed on Academic Separation. In situations of extenuating circumstances, the review committee may offer an extension of Academic Notice II, which would allow the student to enroll in future classes. However, these options will be reserved for students who have demonstrated significant improvement in their academic performance and who provide appropriate supporting documentation.

ACADEMIC SEPARATION

Students placed on Academic Separation will be suspended from the College for one semester. A registration restriction will be placed on the student's account to prevent any attempt to enroll while on Academic Separation. Students who are placed on Academic Separation at the end of the spring semester, will be suspended for both the upcoming summer and fall semesters.

If there are extenuating circumstances, a student may appeal the Academic Separation decision. The student may complete the Academic Separation Appeal Form to be considered for re-instatement by the committee.

At the conclusion of the separation period, students may complete an appeal for re-enrollment privileges. Students who choose to appeal must meet with their academic advisor in order to review and revise his/her academic plan and to complete the Academic Separation Appeal Form (ASAF). The student's completed ASAF must include a detailed explanation of the changes that the student plans to make in order to satisfy the Standards of Academic Progress. This appeal will be submitted to the Student Services faculty committee for consideration.

If the ASAF appeal is granted, the student will be placed on Academic Notice II and must satisfy the requirements of that policy for the privilege of continued enrollment.

However, if the student's appeal is denied, he/she may re-appeal if additional supporting documentation is available, if extenuating circumstances were a factor or after an appropriate time frame has passed as determined by the Student Services faculty committee.

Students who have been placed on Academic Separation for a second or subsequent semester or their appeal was denied by the Student Services faculty committee, may appeal to the vice president of academic services or the vice president of student services. Students who wish to pursue this option must notify the dean of student success in writing of their intent to appeal. The student has the right to submit any additional supporting documentation if available to add to their previous appeal documentation. The decision of the Vice President is final. Further appeals will not be considered until the student can prove substantial academic progress from another institution. Substantial academic progress is defined as a minimum requirement of at least 12 degree/certificate credit hours completed in two consecutive academic years with a minimum of a 2.25 grade point average.

Classroom Etiquette

We are committed to your success, here at Sandburg and have many resources and services to help you. Your success however, begins with you. Successful students at Sandburg adhere to some general classroom policies such as:

- No mobile phones in the classroom. When you are in the classroom, be engaged in the discussion and activities. You will get much more out of the course if you save your texting and social media for later.
- Attendance is expected and crucial to your success in the course. Avoid getting in the habit of skipping class, showing up late or scheduling other appointments during class. You signed up for the class at that time so make sure you are there.
- Show respect to your instructor and classmates. College is a time to learn and grow as a person and be open to new ideas and acceptance of the differences in all of us.
- Adhere to individual classroom policies. Each instructor has the right to establish policies for their class. Read and understand your syllabus and follow the individual classroom and grading policies.
- Take ownership for your success. You will be expected to do a lot of work outside the classroom. Establish your priorities and plan realistically with your time.

Student Harassment & Sexual Harassment

Students may obtain a complete copy of the sexual harassment policy from the Student Services Office.

STATEMENT OF PURPOSE

Carl Sandburg College will not tolerate sexual harassment and is committed to providing and preserving an atmosphere free from harassment in any form. All employees and students have a right to work and study in an environment free from sexual harassment. Sexual harassment is a violation of professional ethics and impedes the primary function of the College.

DEFINITION

Harassment consists of unwelcome conduct, whether verbal, physical or visual, that is based upon a person's protected status, such as sex, race, color, religion, national origin, age, disability, citizenship, marital status, veteran status, sexual orientation, or status in any group protected by applicable federal, state or local law.

Sexual harassment must be of a sexual nature and be perceived as unwelcome. It typically consists of conduct that is either verbal and/or physical but can also take place via text message or social media. Sexual harassment is conduct based on sex, whether directed towards a person of the opposite or same sex, and may include explicit sexual propositions or advances, sexual innuendo, suggestive comments, sexually oriented kidding, teasing or jokes, jokes about obscene printed or visual material or about gender specific traits, display of printed or visual material of a sexual, foul or obscene nature, foul or obscene language or gestures, and physical contact such as patting, pinching or brushing against another person's body.

REPORTING HARASSMENT

Students who believe they are victims of harassment or have witnessed harassment based upon a student's sex, color, race, religion, creed, ancestry, national origin, physical or mental disability, sexual orientation or other protected group status, by another student, a College representative, College personnel or a third party must submit a report of harassment to one of the College's two Equal Employment Opportunity Officers (EEO Officers) immediately. The names and numbers of the College's EEO officers can be retrieved at the Student Services Office or Human Resources.

Harassment that would be considered gender-based or of sexual in nature would fall under Title IX, which is a federal law. Students should report such incidents to Rick Eddy, Title IX coordinator, office E113, **309.341.5234** or

reddy@sandburg.edu.

A report of any form of harassment should ordinarily include the name of the complainant and should always include the name of the alleged harasser, the date(s) of the occurrence(s) and a brief description of this incident.

POLICIES, REGULATIONS & PROCEDURES

POLICY TITLE IX, 2.303/1510/18Title IX

Title IX is a portion of the Education Amendments of 1972 with an emphasis on equal opportunities in education. In accordance with this law, Carl Sandburg College prohibits the discrimination of any person from participation or being denied benefits in any educational program or activity receiving federal assistance on the basis of race, color, religious affiliation, gender (sex), sexual orientation, gender identity or expression, national origin, ancestry, genetic information, age, disability, arrest record status, marital or family status, citizenship status, military status, unfavorable military discharge, sexual harassment, order of protection status and status in any group protected by applicable federal, state and/or local law.

The Campus Sexual Violence Act (Campus SAVE) was signed into law in March 2013 as a new amendment to the Violence Against Women Act of 1994. This act requires college campuses to provide information, training and ongoing prevention and awareness programs to combat sexual violence. Posters and Other Advertising

All posters and advertising must have the approval of the director of marketing & public relations. Posters and advertisements must be brought to the Marketing & Public Relations Office in Room A009 on the Main Campus for posting in any campus building.

Access to & Release of Student Information

It is Carl Sandburg College's policy to comply fully with the Family Educational Rights and Privacy Act of 1974 as amended. Guidelines and regulations for discharge of the College's obligation under this act are contained in the College's *Policy, Regulation and Procedure Manual*, available to students in the President's Office, the Admissions and Records Office or on the Carl Sandburg College website at www.sandburg.edu/About/Board-of-Trustees.

UNDER THESE GUIDELINES:

- Students have the right to inspect their educational records.
- Certain student records may be released only with prior consent of the student.

- Under certain conditions, parents may be granted access to a student's record with or without the student's consent.
- Procedures exist for students to challenge the contents of their educational records.
- The College may release, without the student's consent, information that appears in student directories and publications that are available to the public except when requested by a student to suppress this information. Written requests to suppress this information must be completed within the first five days of classes of the following semester.
- Students have a right to file a complaint with the U.S. Department of Education if they believe the privacy of their education records has been violated.

Drug and Alcohol Abuse

REGULATION ON SUBSTANCE ABUSE

It is the mission of Carl Sandburg College to provide an environment conducive to learning. The illegal use of controlled substances is harmful to the health of the individual and may hinder learning; therefore, the illegal use of controlled substances, as well as their manufacture, distribution, dispensation or possession is prohibited on Carl Sandburg College property or as any part of College activities, events, classes, programs or services.

Students who feel they have a drug abuse problem are encouraged to ask for assistance so as to be referred to an appropriate drug rehabilitation and treatment program. Students with such problems should notify the vice president of student services or a counselor. Behavior that is inappropriate, disruptive and/ or dangerous as a result of the use of illegal drugs will not be tolerated. Students should report such behavior to the vice president of student services. Pending or subsequent to any legal penalties that may be imposed upon the student, the vice president may require the student to participate satisfactorily in a recognized substance abuse program approved by the College. If the student refuses, disciplinary action may be taken and could include:

- 1. A verbal warning
- 2. A written reprimand
- 3. Suspension
- 4. Expulsion from school
- 5. Reporting such person to local, state or federal law enforcement agencies

Visitors using, in possession of or under the influence of a controlled substance will be prohibited from using College facilities and/or reported to appropriate law enforcement agencies.

If the student finds the disciplinary action unjustified, he/she may elect to file a complaint according to the existing complaint procedures of the College catalog or College policy manual.

REGULATION ON ALCOHOL ABUSE

The illegal use or abuse of alcohol by students, visitors or employees is prohibited on Carl Sandburg College property or activities. Behavior that is disruptive or dangerous as a result of the consumption of alcohol will not be tolerated and such behavior should be reported to the vice president of student services.

If a student feels that they have a problem with alcohol, the College will assist in a program that helps with this type of problem. Students with such a problem should notify the vice president of student services or a counselor.

Pending or subsequent to any legal penalties that could be imposed, the vice president may require participation in a recognized alcohol rehabilitation program approved by the College.

If the student refuses, disciplinary action may be taken and could include:

- 1. A verbal warning
- 2. A written reprimand to employees
- 3. Suspension
- 4. Expulsion from school

Visitors using alcohol or who are intoxicated from alcohol will be prohibited from using College facilities. If the student finds the disciplinary action unjustified, he/ she may elect to file a complaint according to existing complaint procedures in the College catalog or College policy manual.

Tobacco-Free Campus Policy

As of July 1, 2015, tobacco use is prohibited on all campus property at Carl Sandburg College, both indoors and outdoors, in College-owned vehicles and in privately owned vehicles parked on campus property. 
