- **Whereas...**Current legislation requires a wind turbine to be directly connected to a bi-directional meter at its owner's billing site for the owner to receive the benefit of "net metering" (which is the method for measuring electricity generated by a wind turbine and offsetting it against the turbine owner's electric bill kilowatt for kilowatt); and
- **Whereas...** This direct-connection requirement prevents wind turbine owners from combining electricity usage from multiple billing sites and offsetting their aggregate usage against the kilowatts generated by their turbines; and
- **Whereas...** "Aggregate net metering" is the method that enables wind turbine owners to combine electricity usage from multiple billing sites (e.g. all school buildings in a school district) and offset that usage against the electricity generated by their turbines, kilowatt for kilowatt; and
- **Whereas...** "Aggregate net metering" must be the law for the Abingdon Wind Energy Consortium to be able to establish a collectively owned wind turbine farm at a location remote from member districts' school buildings; and
- **Whereas...** Legislation has been introduced into the Illinois General Assembly that requires retail electricity providers to allow "aggregate net metering".

RESOLUTION

WHEREAS, in 1965 the Illinois Community College system was established in state law, and in 1966 Carl Sandburg College was established locally, and all community colleges were designated as "special districts" under the Illinois Constitution of 1970, and as such, they are considered "units of local government"; and

WHEREAS, in 2003 the Illinois General Assembly approved the "State Government Officials and Employees Ethics Act" (the Ethics Act) which became state law; and

WHEREAS, in October 2005, the Illinois Attorney General issued a legal opinion that states in part "that community college districts are 'special districts' under the Illinois Constitution of 1970. As such they are considered 'units of local government'." The opinion continues to state "Because community colleges districts constitute 'public institutions of higher education'... they fall within the definition of 'State Agency' as the term is used in the Ethics Act. Because the definition of 'State Agency' includes community college districts, it is my opinion that they... are not government entities authorized to adopt their own ethics ordinance or resolution. Rather community college districts and their employees must comply with the Ethics Act for State Agencies and State employees and the personnel policies established by the Illinois Community College Board"; and

WHEREAS, initial research reveals that there appears to be no legislative intent to consider community college districts as State Agencies under the Ethics Act; and

WHEREAS, local government autonomy and local control of community college districts could be threatened under the provisions of this opinion; and

WHEREAS, Carl Sandburg College is in compliance with the requirements of the Ethics Act as determined by state law pertaining to "units of local government"; and

WHEREAS, Carl Sandburg College wishes to maintain high ethics standards and policies;

THEREFORE, BE IT RESOLVED that the Board of Trustees of Carl Sandburg College authorizes the administration to work to clarify the intents and applications of the Ethics Act to community colleges;

AND BE IT FURTHER RESOLVED that the administration is authorized to explore all possible avenues of gathering information;

AND BE IT FURTHER RESOLVED that the Board of Trustees authorizes the President to accept the information, make decisions and take actions consistent with, and limited to, the authority routinely delegated to the President, that he determines to be in the best interest of Carl Sandburg College; and

AND BE IT FURTHER RESOLVED the President of Carl Sandburg College shall keep all trustees informed of his decisions;

AND BE IT FURTHER RESOLVED Carl Sandburg College shall work closely with the Illinois Council of Community College Presidents and the Illinois Community Colleges Trustees Association to achieve the best possible results;

AND BE IT FURTHER RESOLVED that Carl Sandburg College shall consider participating in a plan to share the expenses of these efforts among the various participating community colleges.

RESOLUTION AUTHORIZING ESTABLISHMENT OF THE STRATEGIC TECHNOLOGY ENDOWMENT FUND (STEF)

WHEREAS, the Board of Trustees of Community College District No. 518, counties of Fulton, Hancock, Henderson, Henry, Knox, McDonough, Mercer, Schuyler, Stark and Warren and State of Illinois, also known as Carl Sandburg College, (herein referred to as the Board of Trustees) previously approved Phase III of the SMART Initiative (Strategic Management and Resources Together) at its regular meeting held May 18, 2000, involving a sale/leaseback of real property (Building E), and

WHEREAS, the Board of Trustees, subsequently approved entering into a Capital Lease with American National Bank & Trust Company as authorized under the auspices of Section 17b of the Local Government Debt Reform Act of Illinois, and

WHEREAS, one of the expressed purposes of the SMART Initiative - Phase III is to establish a permanent \$5M Strategic Technology Endowment Fund (STEF) with the interest income generated therefrom to be designated for the purpose of refreshing the college's strategic technologies, and

WHEREAS, the administration has completed an analysis of applicable regulations and accounting procedures to be adhered to, including input from the college attorney (Mr. Tom West); the college's bonding attorney (Chapman & Cutler); the college's external auditor (Clifton Gunderson L.L.C.) and the Illinois Community College Board Fiscal Management Manual (Mr. Don Wilske, Chief Financial Officer).

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the Board of Trustees of Community College District No. 518, Counties of Fulton, Hancock, Henderson, Henry, Knox, McDonough, Mercer, Schuyler, Stark and Warren and State of Illinois, that the Treasurer of this Community College district is directed to:

- 1. Establish a Quasi-Endowment Fund herein after referred to as the Strategic Technology Endowment Fund (STEF), featuring a self-balancing set of accounts in accordance with the Illinois Community College Board (ICCB) Fiscal Management Manual.
- 2. Deposit, and maintain in perpetuity, a minimum principal balance of \$5M into said STEF Fund from the proceeds of Phase III of the SMART Initiative approved by the Board of Trustees May 18, 2000.
- 3. Incorporate recommendation(s) into the development of the college's annual operating budget so as to maintain the initial \$5M in purchasing power of the STEF Fund.

BE IT FURTHER RESOLVED that this resolution shall be in full force and effective from and after its adoption this 27^{th} day of July 2000.
